Incentive Program: You may be eligible for our volume discount program. This discount will automatically be computed and credited at billing time whenever monthly purchases reach the following volumes:

- 2000-4999 Gallons = 1 1/2 cents on all gallons purchased that month
- 500-1999 Gallons = 1 1/2 cents on all gallons purchased that month
- 2000-4999 Gallons = 3 cents on all gallons purchased that month
- 5000-9999 Gallons = 4 cents on all gallons purchased that month
- 10000+ Gallons = 5 cents on all gallons purchased that month

Credit Disclosure: The undersigned applicant/buyer ("Applicant") represents that the information given in this application is complete and accurate and authorizes Quality Oil Company, LLC ("Card Issuer") to check with credit reporting agencies, credit references and other sources disclosed to confirm information given. Applicant requests a business charge account, if approved for credit, and one or more business charge cards from Card Issuer. All charges must be paid in full regardless of disputes. Charges must be disputed in writing no later than thirty (30) days from the billing date or they will be considered final and binding.
